**Subject: Terms of Reference**

Dear Mr. Kabir,

Greetings from MRDI! You are aware that MRDI is implementing a project '**Strengthening News Media Freedom and Accountability in Bangladesh**' in partnership with The Asia Foundation aiming to support the Media Reform Commission according to its needs before submitting final recommendations to the Interim Government.

With your technical knowledge and support, we helped the Media Reform Commission to draft the 'National Media Commission Ordinance, 2025' on the basis of recommendations generated from consultation and interaction with different stakeholders, which were also acknowledged and highly appreciated by the commission.

Recently the reform commission requested for support from MRDI in developing another ordinance on "Journalist Protection".

Considering your expertise and understanding of legislation and relevant issues and recent support to draft the National Media Commission Ordinance, we are requesting your support to draft the ordinance under the following terms and conditions:

1. Prepare the draft of Journalist Protection Ordinance in consultation with the chair of the Media Reform Commission along with the Executive Director of MRDI and the team.
2. Present the draft before the chair of Media Reform Commission and the MRDI team.
3. The duration of the assignment will be **from the date of signing to 20 March 2025**.
4. A total of BDT 650,000.00 (Six lac and fifty thousand) only will be paid as honorarium for the above-mentioned assignment.
5. 50% of the honorarium will be paid after placing the 1<sup>st</sup> draft of the Ordinance and the remaining 50% will be paid after final presentation to MRDI.

7. VAT/TAX as admissible will be deducted at source as per Bangladesh Govt. rules.
8. Child protection code of conduct form acknowledgment is required.



### Child Protection Code of Conduct

I, **Md. Moinul Kabir**, acknowledge that I have read and understood MRDI's *Child Protection Policy* under the Financial and Administrative Manual and agreed that in the course of my association with MRDI, I **must**:

- treat children with respect regardless of race, colour, gender, language, religion, political or other opinion, national, ethnic or social origin, property, disability, birth or other status
- not use language or behaviour towards children that is inappropriate, harassing, abusive, sexually provocative, demeaning or culturally inappropriate
- not engage children under the age of 18 in any form of sexual intercourse or sexual activity, including paying for sexual services or acts
- wherever possible, ensure that another adult is present when working in the proximity of children
- not invite unaccompanied children into my home, unless they are at immediate risk of injury or in physical danger
- not sleep close to unsupervised children unless absolutely necessary, in which case I must obtain my supervisor's permission, and ensure that another adult is present if possible
- use any computers, mobile phones, video cameras, cameras or social media appropriately, and never to exploit or harass children or access child exploitation material through any medium
- not use physical punishment on children
- not hire children for domestic or other labour which is inappropriate given their age or developmental stage, which interferes with their time available for education and recreational activities, or which places them at significant risk of injury
- comply with all relevant legislation, including labour laws in relation to child labour
- immediately report concerns or allegations of child exploitation and abuse and policy noncompliance in accordance with appropriate procedures
- immediately disclose all charges, convictions and other outcomes of an offence, which occurred before or occurs during my association with MRDI that relate to child exploitation and abuse.

**When photographing or filming a child or using children's images for work-related purposes, I must:**

- assess and endeavour to comply with local traditions or restrictions for reproducing personal images before photographing or filming a child
- obtain informed consent from the child and parent or guardian of the child before photographing or filming a child. As part of this I must explain how the photograph or film will be used

- ensure photographs, films, videos and DVDs present children in a dignified and respectful manner and not in a vulnerable or submissive manner. Children should be adequately clothed and not in poses that could be seen as sexually suggestive
- ensure images are honest representations of the context and the facts
- ensure file labels, meta data or text descriptions do not reveal identifying information about a child when sending images electronically or publishing images in any form.
- I understand that the obligation is on me, as a person associated with MRDI, to use common sense and avoid actions or behaviors that could be construed as child exploitation and abuse.
